

ONE DISH ONE STORY CONTEST

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: The ONE DISH ONE STORY CONTEST ("Contest") is open to legal residents of the contiguous United States and the District of Columbia, excluding Rhode Island, , who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Employees, officers and directors (including immediate family members (spouse, child, sibling, parent and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of L.A. Live Properties, LLC (the "Sponsor"), Anschutz Entertainment Group, Inc., and BBVA USA ("BBVA USA "), and each of their respective parents, affiliated companies, subsidiaries, advertising and promotion agencies associated with the Contest are not eligible to participate or win a prize. The Contest is subject to all applicable federal, state and local laws, rules and regulations. OBJECT OF CONTEST: The object of the Contest is to submit an original photo and the name of a Spanish dish you created, along with a short description sharing a personal story or life moment involving your dish (the "**Submission**"). Sponsor's staff members will judge all eligible entries received based on criteria set forth in the Judging section below.

HOW TO ENTER: The Contest begins at 10:00 a.m. Pacific Daylight Time ("PDT") on August 26, 2019 and ends at 11:59 p.m. PDT on September 9, 2019 ("Entry Period"). During the Entry Period, there are two (2) ways to enter: Twitter and Instagram. No other methods of entry will be accepted. Limit one (1) entry per person, per e-mail address, per social media account, and per household. Multiple entries received from any person or e-mail address, social media account, or household in excess of the stated limitation will be void. You must complete all required information in order to be eligible. Any attempt by a person to enter more than once with multiple accounts may result in disqualification at the discretion of Sponsor upon verification of prize winner. All information and files submitted in format specified will become property of Sponsor, and used as provided in the Sponsor's Terms of Use and Privacy Policy, each of which can be found by visiting <https://www.lalive.com/privacy-policy> and <https://www.lalive.com/terms-of-service> (both of which are incorporated herein by reference).

Twitter's clock will be the official time keeper for this Contest. If you make or receive tweets on your mobile phone, standard data fees may apply. See your wireless provider for pricing plan details. In order to participate in the Contest without receiving tweets on your mobile phone, be sure to deactivate your mobile phone from your Twitter account.

2. Instagram Method: During the Entry Period, in order to enter the Contest through Instagram you must (a) be a registered user of Instagram with a public profile. Registration is free and can be done by visiting <http://instagram.com>, (b) follow @AllStarChefLA and @bbva_usa, and (c) upload one (1) original photo and name of your spanish dish that you created, along with a short description sharing a personal story or life moment involving your dish, using the hashtags #onedishonestory and #CreatingOpportunities. If you choose to enter via Instagram using your mobile phone, standard data fees may apply. See your wireless provider for pricing plan details. All eligible entries will be posted on #onedishonestory and #CreatingOpportunities.

Images must be in digital format. No print or film submissions will be accepted for entry into this Contest. All digital files must be 3 megabytes or smaller in JPEG or JPG format. The image need not be taken with a digital camera; scans of negatives, transparencies, or photographic prints are acceptable. By submitting your completed entry as directed, you will receive one (1) entry in the Contest.

This Contest is in no way sponsored, endorsed or administered by, or associated with Twitter or Instagram. You are providing your information to Sponsor and not to Twitter or Instagram.

WINNER. One (1) Winner (the “Winner”) will be selected in all, based on the judging criteria below on or about September 10, 2019 (the “Judging Date”).

JUDGING: A panel of Sponsor staff members will judge all eligible entries received. Eligible entries will be judged on the following basis:

1)	Dish story or life moment	50%
2)	Dish creativity	25%
3)	Dish name/presentation	<u>25%</u>

On or about September 10, 2019, the entrant who submitted the entry with the highest score based on the criteria above as determined by the judges in their sole discretion, will be the potential winner (“Winner”), subject to verification of eligibility and compliance with the terms of these Official Rules. In the event of a tie, an additional, tie-breaking judging will determine the Winner from among such tied entries using the judging criteria outlined herein. Sponsor reserves the right to not award the prize if, in its sole discretion, it does not receive a sufficient number of eligible and qualified entries. The decisions of Sponsor are final and binding on all matters relating to this Contest. Odds of winning depend on the total number of eligible entries received. Limit one (1) prize per person, per family, per social media account, and per household.

PUBLICATION AND ASSIGNMENT OF RIGHTS TO SUBMISSIONS: By entering the Contest, each entrant agrees that his or her submission is an original work of authorship and he or she owns all right, title and interest in the entry as of the date of submission.
